Guild Hall presents more than 200 programs and hosts 60,000 visitors each year. The Museum mounts eight to ten exhibitions, ranging from the historical to the contemporary, and focuses on artists who have an affiliation with the Hamptons. The Theater produces more than 100 programs—including plays, concerts, dance, screenings, simulcasts, and literary readings—from the classics to new works. In addition to these endeavors, Guild Hall supports the next generation of artists with in-school and on-site Learning & Public Engagement programs.

FROM THE EXECUTIVE DIRECTOR

Thank you to our artists, trustees, staff, and patrons for seeing us through a most unusual period of accelerated evolution. From 2020 to 2021, we saw the growth of our streaming and hybrid programming, partnerships with a broad range of cultural institutions, an expanded residency for community artists-in-residence and collectives, and more resources devoted to learning and public engagement. We channeled the bulk of our artist and performer fees to creative professionals in our community and learned new ways to make things happen regardless of the hurdles. This is the definition of creativity.

We have taken the lessons learned from the pandemic and begun to envision Guild Hall as an interdisciplinary institution for the 21st century. IMPACT

Guild Hall is at the center of arts and culture on the East End. The 91-year-old institution helps directly and indirectly to support dozens of local arts organizations and community groups and contributes to a broader range of how the community presents art. Guild Hall is home to the largest theater in the Town of East Hampton, and the performance space is frequently rented to local organizations at subsidized rates. Many of these smaller arts and culture organizations rely on the use of Guild Hall's spaces to support the community in their own ways.

Long Island arts and cultural organizations spend \$1.8 billion annually. If we assume that 50% of that spending takes place on the East End, and that Guild Hall is at the center of just 10% of all East End arts activity, Guild Hall accounts for \$90 million in economic activity each year.

In 2020, Guild Hall enlisted the expertise HR&A Advisors to conduct a study to quantify our direct and multiplier economic impacts on Suffolk County and tax revenue to Suffolk County and the State of New York from five overarching categories: Guild Hall's capital renovations, operations, Main Street spending, A-Level event visitor spending, and incremental property tax value.

Summary of Economic & Fiscal Impact Findings

- Jobs: 209 construction jobs and 238 year-round and seasonal jobs at Guild Hall and other local businesses
- Wages: \$13.4 million in construction wages and \$7.8 million annually in year-round and seasonal job wages
- Economic Output (spending): \$39.0 million in total economic output from construction spending and \$24.5 million annually in economic output from ongoing Guild Hall operations and ancillary visitor spending
- New York State Tax Revenue: \$12.0 million in State tax revenue over 20 years
- Suffolk County Tax Revenue: \$7.9 million in County tax revenue over 20 years
- Local Property Tax Revenue: \$17.8 million in property tax revenue over 20 years generated in the Towns of East Hampton and Southampton

2020 was a year where everyone's plans had to change. We were thrilled that Robert Longo helped lead the way with ALL FOR THE HALL a benefit exhibition that brought in over \$420,000 in sales from works donated by 60 artists. Guild Hall was the first museum on Long Island to re-open to the public during COVID-19 with safety protocols in place. We expanded our virtual offerings with top-notch programming led by artists such as Shirin Neshat and Renee Cox and hosted over 40 virtual one-on-one studio visits engaging our community artists.

Despite all of the difficulties and obstacles, in 2021 we were able to present a full year of exhibitions starting with the 83RD ANNUAL ARTIST MEMBERS EXHIBITION, followed by two one-person exhibitions featuring the work of mid-career artists KARIN WAISMAN and ENOC PEREZ. Summer exhibitions included ALEXIS ROCKMAN: SHIPWRECKS, curated by Executive Director Andrea Grover, and ROBERT LONGO: A HISTORY OF THE PRESENT. The fall season featured 90 YEARS: SELECTIONS FROM THE PERMANENT COLLECTION and JEFF MUHS: AN UNCANNY VALLEY. All exhibitions were accompanied by a series of public programs including gallery talks, panel discussions, and film screenings.

LEARNING + PUBLIC ENGAGEMENT

2020 can be distilled into three words: innovation, flexibility, and support. Throughout the year, Guild Hall Learning + Public Engagement advanced traditional programs, strengthened community partnerships, and provided creative and financial support to young and seasoned artists at a crucial time.

In 2020, the Community Artist-in-Residence Program was created. In two years, the program supported 6 individual artists and 1 artist collective, resulting in 5 exhibitions and 1 theater production. Guild Hall also welcomed 6 artists, both virtually and in-person, as part of the 2021 Guild Hall Artist-in-Residence program.

In 2021, "GATHER: Conversations led by Black and Indigenous Change-Makers" was established in partnership with Ma's House & BIPOC Studio on Shinnecock Indian Reservation.

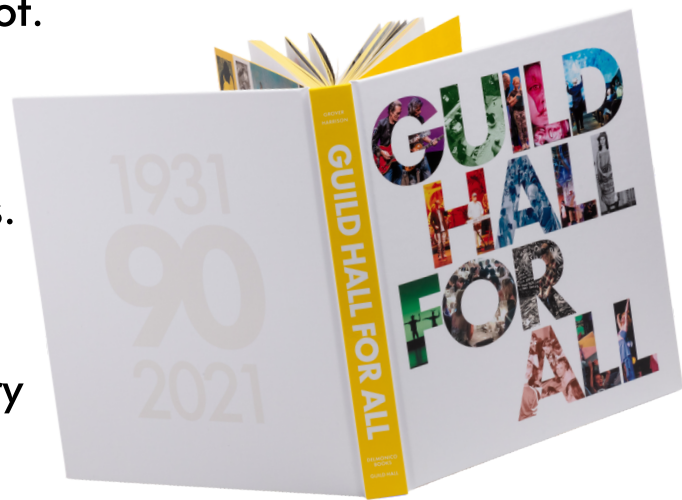
